I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or conduct of the owners, agents, officers, employees, or members of Boy Scouts of America and the Waterloo Jaycees, or by any other person. I, on behalf of myself, my children, my spouse, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Boy Scouts of America and the Waterloo Jaycees and its owners, agents, officers, employees, and members from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of the above equipment or my participation in this activity. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers, employees, or members of Boy Scouts of America and the Waterloo Jaycees.
