



WATERLOO JAYCEES 30TH ANNUAL CANOE RACE

GENERAL INFORMATION: Race begins Saturday, June 12th at 10:00 a.m. at the Main Street Bridge in Cedar Falls, Iowa. Registration is a 9:00 a.m.

RULES:

1. Each contestant will be required to have a Coast Guard approved life jacket in his/her possession during the race.
2. USCA specifications apply to all cruising canoes, kayaks, and paddles.
3. Each participant under the age of 18 must have a parent/guardian's signature on the consent and waiver liability form.
4. Prizes will be awarded to the first three places in each class.
5. All protests must be submitted in writing to the race chairperson within ½ hour of the race finish.
6. If there are less than four entries in any class, Waterloo Jaycees reserve the right to combine classes.
7. In the adult/child class, the adult must be over 29 and the child under 15.

RECREATIONAL CLASS CANOES: Any canoe 17 feet or shorter or standard recreational dimensions. Canoes can be made of any material, but must weigh 55 pounds. Canoes in this class will be accepted by appearance and intended purpose of construction rather than just by dimensions. Example canoes: We-No-Nah 17 ft. Jensen, Spirit or Echo, Sawyer X-17, Sawyelex 17, all standard aluminum canoes like Grumman, Michi-Craft, Osagian, Royalex canoes such as the Mad River Explorer, etc.

EXCEPTION – All recreational canoes greater than 17 feet shall race in the Open – High Performance Division regardless of paddler's gender or age. Example canoes: We-No-Nah Sundowner, Minnick Aluminum Racer, 18 foot Jensen, Beaver Aluminum, Sawyer 17ft. 9 in., etc.
